

# Introduction

More and more, people are becoming dependent on their mobile phones to handle their daily activities. Things like purchasing event tickets, ordering food for delivery, hailing rides, depositing checks and much, much more can all be done via mobile phone apps.

According to Pew Research, 77% of Americans currently own smartphones and that number will only continue to increase as time goes on. These are the results of the study, broken down by category:

- Single pages will often come in high resolution files as large as 20 mb.
- Photographs are not compatible with




scan and populate solutions until the firm manually converts them to PDF.

- Documents are often difficult to read due to lighting, blurred focus and distracting backgrounds.
- Files are not secure when sent via email.

## How Banks Tackled Clients Delivering Electronic Documents




The banking industry dealt with a similar dilemma during the transition to the digital age. Years ago, banks began allowing customers to deposit checks electronically. However, they foresaw the complication of receiving blurry, poorly lit photos of checks that are barely legible. To counter this issue, they developed mobile apps with the ability to control the image quality. This function ensures the image is in focus, eliminates the background of the photo and minimizes the file size.

You can still walk into a bank branch and walk up to a teller, but ever since giving clients digital options, banks have been able to substantially reduce the administrative cost that comes with handling deposit transactions. Moreover, by automating the process they have greatly reduced the number of in-person transactions without losing any business. Some major banks have even been able to reduce the number of physical branches while maintaining the same amount of business, resulting in tremendous savings.

## TaxCaddy Features Overview

On the clients' end, the TaxCaddy website and mobile app have a simple and functional interface. The homepage gives a generalized overview of the features, and users can access Tax Pro Requests and Smart Links along with a one-click document uploader.



Within the **Tax Pro Request** section, the process begins with a customized questionnaire to give CPAs answers to the questions they need to prepare the tax return. Feedback has shown that users strongly prefer digital questionnaires that can be completed on the go as opposed to filling out a paper form.



For documents that need to be signed, such as engagement letters, statements of work and the e-file authorization, TaxCaddy offers an easy to use e-signature feature.

In addition to quickly signing documents, clients can deliver the requested documents in three easy ways.

1. Upload documents from their PC, Mac, tablet or phone (and even upload from storage services like Dropbox or Google Drive)
2. TaxCaddy's Smart Links will automatically retrieve documents from leading financial institutions
3. Photoscan documents with the TaxCaddy app for iPhone and Android

Taxpayers can also mark requested document as "already provided" or "does not apply". In instances where the taxpayers



doesn't have the requested document because it's provided by the CPA, like a K-1, the tax professional can upload it to TaxCaddy on behalf of the client.


If the request list is missing documents that the client believes are relevant, clients can select "I have other documents that aren't listed here," which allows them to upload tax information that was not asked for but may be vital to the return. These documents can also



be uploaded from the home page under the generalized "+Add a Document" button. From there, users select from a list of document types to classify the file and are given the option to sort by "Popular" or "All" in order to speed up their search. After selecting the document type, taxpayers can fill in subcategories and TaxCaddy will suggest a name for the file, leaving the option open to change it. Once the category is selected, the process is complete and the document is uploaded.

If your clients email you photographs of documents, they'll love the TaxCaddy app for iPhone and Android. TaxCaddy's photoscanning function creates the best scan-quality PDFs possible. The app informs users to hold the phone still and automatically captures the image once the document is clear and within the borders. With the background eliminated from frame, users are then given the option to retake the photo, edit it or continue taking photos of additional pages. Since TaxCaddy uses banking security protocols like 4096-bit Secure Socket Layer encryption, document transfers are secure. Say goodbye to documents being delivered to you via unsecure email.

Another convenient and time saving feature in TaxCaddy is **Smart Links**. Smart Links automatically retrieve tax documents without requiring you or the client to lift a finger. Once the taxpayer links their banks, brokerages and payroll service provider,



TaxCaddy checks for new source documents once per day and automatically uploads them to the document request list as soon as they become available. Smart Links are especially beneficial for firms since the retrieved documents are native PDFs, ensuring 100% OCR accuracy when run through [1040SCAN](#).

To maintain a productive stream of communication between the firm and client, taxpayers can securely message the CPA through TaxCaddy with any questions or concerns. For the sake of clarification, messages may be linked to specific documents that the question pertains to and the message recipient can be notified immediately.


